IBHE ADMINISTRATIVE RULES: REGULATORY AGENDA

This item submits for Board action a Regulatory Agenda, as required by the *Illinois Administrative Procedure Act*, to be published in the *Illinois Register*. The Regulatory Agenda serves as a planning mechanism for the Board and a public communication of the Board's intent to review specific rules during the upcoming year. The attached Regulatory Agenda highlights the following rules to be reviewed and amended (as needed) during 2008:

- Program Review Private Colleges and Universities (23 Ill. Adm. Code 1030) and Program Approval - Public Colleges and Universities (23 Ill. Adm. Code 1050). The Board has established a working group to review policies for approval and review of new institutions and new program proposals. Findings of this review may necessitate proposed amendments.
- A Master Plan for Postsecondary Education in Illinois (23 Ill. Adm. Code 1070). A portion of the rules currently on file may not accurately reflect the current Master Plan Policies as previously adopted and subsequently amended by the Board. These rules will be reviewed and updated in accordance with the Board's review of the Master Plan for Illinois higher education.
- Task Force on Higher Education and the Economy (23 Ill. Adm. Code 1070). On July 26, 2007, both Houses of the 95th General Assembly adopted House Joint Resolution No. 69 which directs the Board Chairperson to "study the challenges and opportunities facing higher education, the State's workforce needs, demographic trends, and higher education funding and student financial aid." The recommendations of the task force may also result in rule review and amendments in the future.
- Health Services Education Grants Act (23 Ill. Adm. Code 1020), Nurse Educator Fellowship Program (23 Ill. Adm. Code 1105), and Nursing School Grant Program (23 Ill. Adm. Code 1100). Staff plans to review the current rules in light of critical workforce need determinations of the State and diminishing resources.
- Public Information, Rulemaking, and Organization (2 Ill. Adm. Code 5050). On November 1, 2007, Governor Rod Blagojevich signed into law Public Act 94-905 amending the Board of Higher Education Act [110 ILCS 205/9.10] to abolish the Joint Education Committee (JEC). Proposed amendments will update the rule currently on file.
