IBHE ADMINISTRATIVE RULES: JANUARY 2019 REGULATORY AGENDA

The January 2019 Regulatory Agenda serves as a planning mechanism for the Board and a public communication of the Board's intent to adopt new rules and review existing rules during the upcoming year. The attached Regulatory Agenda highlights the following rules to be reviewed and amended (as needed) during 2019:

- a) Illinois Financial Assistance Act for Nonpublic Institutions of Higher Learning (23 Ill. Adm. Code 1000). The Board will review the existing rule for implementation of the newly adopted rules for the Grants Accountability and Transparency Act (44 Ill. Adm. Code 7000). Findings of the review may result in proposed amendments in 2019.
- b) Reverse Transfer of Credits (23 Ill. Adm. Code 1065). Pursuant to Public Act 100-824, the Board of Higher Education and the Community College Board shall adopt rules to implement new legislation regarding reverse transfer of credits. Beginning with the 2019-2020 academic year, students may apply for the transfer of earned academic credit from a state university to a community college for the purpose of obtaining an associate degree at a community college.
- c) Approval of New Units of Instruction, Research, and Public Service at Public Institutions (23 Ill. Adm. Code 1050). The Board may review this rule in 2019. Findings of the review may result in proposed amendments.
- d) **Program Review Private Colleges and Universities (23 Ill. Adm. Code 1030).** The Board may review this rule in 2019. Findings of the review may result in proposed amendments.
- e) **Private Business and Vocational Schools Act (23 Ill. Adm. Code 1095).** The Board may review this rule in 2019. Findings of the review may result in proposed amendments.
- f) **Diversifying Higher Education Faculty in Illinois Program (23 Ill. Adm. Code 1080).** The Board will review the existing rule for implementation of the newly adopted rules for the Grants Accountability and Transparency Act (44 Ill. Adm. Code 7000). Findings of the review may result in proposed amendments in 2019.
- g) General Grant Programs (23 Ill. Adm. Code 1001). The Board will review the existing rule for implementation of the newly adopted rules for the Grants Accountability and Transparency Act (44 Ill. Adm. Code 7000). Findings of the review may result in proposed amendments in 2019.

- k) Postsecondary and Workforce Readiness Act (23 III. Adm. Code 1034). Pursuant to Public Act 99-674, the IBHE may adopt such administrative rules as may be necessary to support instruction in transitional mathematics and in reading and communication transitional competencies. Implementation is subject to the availability of public or private resources for its administration. The Board may promulgate rules in 2019.
- 1) Performance Metrics for Budget Recommendations (23 III. Adm. Code 900). Pursuant to Public Act 97-320, performance metrics designed to promote and measure student success in degree and certificate completion must be adopted by the Board by rule. The first set of metrics was developed in accordance with principles defined in the Public Act for the Board's Fiscal Year 2013 budget recommendations for higher education. The Board intends to adopt new rules in 2019.
